ZIA NATURAL GAS COMPANY APPLICATION FOR GAS SERVICE

Terms and Conditions

Zia Natural Gas Company, ("the Company") is hereby requested to provide gas service at the location herein described (the "premises"), and to furnish, own and maintain metering and regulating equipment located on the premises, and the Customer agrees to take and pay for such service. As a condition to such service, it is understood and agreed as follows:

- 1. All private service lines, piping, appurtenant facilities, and gas-burning appliances or equipment (excluding metering and regulating equipment), located on or within the premises, shall be owned, maintained and controlled by the Customer and/or premises' owner in accordance with the Company's rules, tariffs, and other applicable laws and regulations as amended from time to time. Except as otherwise required by law, the Company is in no way responsible for the inspection, testing, maintenance, or repair of equipment or facilities not owned by the Company.
- 2. The Customer agrees to pay for gas service at the Company's established rates as amended and changed from time to time, plus all sales, use, excise and other taxes and fees. The Customer further agrees to abide by the Company's present and future rules, tariffs and other applicable laws and regulations as a condition of gas service.
- 3. The Customer agrees that the Company will have the right of access to the Customer's premises at reasonable times for the purpose if installing, reading, inspecting, testing, maintaining, or repairing metering and regulating equipment, or for the purpose of removing its property, and for all other proper and lawful purposes. The Customer shall properly protect the Company's property located on the premises.
- 4. The Company shall not be liable for damages due to interruptions in service and the Customer shall hold the Company harmless from any and all claims or liability for damage or injury to persons or property which may arise out of or be caused by the construction, maintenance, use, or operation of service lines, piping, facilities, equipment, or appliances which are located on the premises.
- 5. For gas service requiring conversion to natural gas from an alternative fuel source: Customer understands that in some cases the conversion to natural gas of a Customer-owned appliance may result in the nullification of the manufacturer's warranty for the Customer-owned appliance.
- 6. Customer agrees that in the event the manufacturer's warranty is nullified by the conversion to natural gas by a Company representative, that Customer shall be fully responsible and shall hold the Company harmless for any and all claims which may have been covered by the manufacturer's warranty.
 - 7. This application pertains solely to one meter to be installed at the premises. Separate applications will be required for other meters or locations.
- 8. It is further understood and agreed that I will be billed a minimum base charge \$______plus gas consumption upon installation of service line and meter commencing with the Company's next applicable billing cycle.

Excess Flow Valve Notification for Residential Customers

As required by the U.S. Department of Transportation (DOT) pipeline safety regulation, 49 CFR 192.383, you are hereby notified that an excess flow valve ("EFV") which meets the minimum DOT performance standards is available for installation on your natural gas service line that operates continuously throughout the year at a pressure not less than 10 psig and does not meet the conditions of 49 CFR-PART 192.383 paragraph (c). Please note that an EFV is not required for the normal, safe operation of your service line, but could help mitigate the consequences of a service line break or rupture.

An EFV is designed to shut off and/or significantly restrict the flow of natural gas automatically if the service line to the customer breaks due to excavation, earthquakes, fire, run over meter sets, augers or other causes. A service line is the piping from the gas distribution main to the customer meter set and may run underground through the customer's yard. EFVs generally do not protect against slow leaks like those caused by loose fittings or leaks beyond the gas meter such as house piping and customer appliances. While the use of an EFV may help to limit the effects of such an incident, the best way to avoid excavation damages is to ensure that those who may have reason to be excavating on your property call 811 prior to digging.

Installation of an EFV is not mandatory. However, if you would like to have an EFV installed in an existing natural gas service line, Zia Natural Gas Company will complete such an installation at a mutually agreeable date for a base cost of \$600 when installed in a plastic service line or a base cost of \$950 when installed in a steel service line. These costs are for labor and material only, and do not include cost(s) associated with local excavation permits, paving, or landscaping work that may be required following the installation. Such costs, if any, will be the responsibility of the property owner. A cost estimate will be provided by Zia Natural Gas Company upon request.

Zia Natural Gas Company makes no warranties, expressed, implied or otherwise, for continued proper excess flow valve operation under any use conditions and/or for inadvertent valve closure under varying gas system operating conditions.
