Zia applies to the New Mexico Public Regulation Commission

On Monday, April 19, 2021, Zia Natural Gas Company ("Zia") applied to the New Mexico Public Regulation Commission ("NMPRC") in Case No. 21-00096-UT for emergency authorization to adjust its Gas Cost Factor for gas sales after May 1, 2021. The cost of purchasing and transporting gas to Zia's system is passed directly through to the customer as the Gas Cost Factor. A regulated utility is not allowed to make or lose money of the cost of gas. The change in the Gas Cost Factor is due to a very specific Extreme Pricing Event in the natural gas market that occurred for a week in February of 2021. The bill impact and proposed Gas Cost Factor are provided for your review in the table.

From February 13 to 17 of 2021, Winter Storm Uri hit a large portion of the middle of the United States sending temperatures plummeting and energy usage skyrocketing. Winter Storm Uri had a major impact on the state of Texas straining the electrical grid to the point that many people were out of electricity for days. Unfortunately, as electricity producers scrambled

to fill the gap left by the loss of renewable energy and the lack of natural gas from frozen production, the wholesale market price for natural gas, which is unregulated, rose astronomically. Facing high demand from customers, natural gas utilities throughout a large swath of the U.S. had no choice but to pay extraordinarily higher prices for natural gas to keep the gas flowing to their own customers. Although, for a regulated natural gas utility, the cost to purchase and transport gas is a direct pass-through cost, the upset in the natural gas market will have a major impact on both natural gas and electric customers for several years.

Zia Natural Gas Company provides natural gas service to approximately 39,500 customers throughout New Mexico.

The cold weather event that occurred in February of 2021 did not affect Zia's supply of natural gas to its customers, but had a very large financial impact on Zia through its gas purchases to supply its customers' higher demand for natural gas. Zia had to immediately seek approval for financing to be able to pay the natural gas bills due at the end of March.

Overall, Zia spent approximately \$19.6 million in February to purchase and transport gas to Zia's system, including fees. After analyzing the invoices from February, Zia determined the normal February cost to be \$1.9 million and the extraordinary cost incurred for its customers to be \$17.7 million. In comparison, Zia's annual gas purchase last year was approximately \$10 million. Due to the major financial impact of this unprecedented price spike on the business, Zia had to immediately file for approval by the NMPRC to begin recovering the costs from customers. Zia requests to spread the costs for that 7-day period out over a 17-month period instead of its normal 12-month period. Zia paid its gas supply bills to ensure its continuing supply to serve its customers, but protested the extraordinary costs, and is cooperating with the New Mexico Attorney General's and the NMPRC's investigations into the

market pricing event. If any restitution comes from these or other investigations and Zia receives a settlement credit or refund, that amount would also flow back to Zia's customers.

As always, Zia Natural Gas Company encourages all of their customers to winterize their homes and conserve energy by lowering the thermostat when not at home. For customers who do need help with winter heating bills, assistance is available through the Low-Income Home Energy Assistance Program (LIHEAP) at the local Human Services Division office or call (800)283-4465. Tacos On A Stick

A southwestern twist on traditional shish kabobs

Ingredients:

1 Envelope of Taco Seasoning	1 medium sweet red pepper, cut into chunks
1 Cup tomato juice	1 large onion cut into wedges
2 Tablespoons canola oil	16 cherry tomatoes
2 pounds of beef top sirloin steak, cut into 1-inch cubes	Salsa con queso or sour cream, optional
1 medium green pepper, cut into chunks	

Directions

In a large shallow dish, combine the taco seasoning, tomato juice and oil; mix well. Remove ½ cup for basting; refrigerate. Add beef to dish and turn to coat. Cover; refrigerate for at least 5 hours.

Drain and discard marinade. On metal or soaked wooden skewers, alternately thread beef, peppers, onion and tomatoes. Grill, uncovered, over medium heat for 3 minutes on each side. Baste with reserved marinade. Continue turning and basting until meat reaches desired doneness, 8-10 minutes. If desired, serve with salsa con queso or sour cream.
